**Title:** Towards a Digital Effectiveness of Consumer Protection Through Self-Executing Remedies and ADR Systems: An Empirical Approach to European Private Law

The research will deal with touristic services, in order to identify and promote tools and models for the effective protection of travellers in both a preventive and deflective function. It will be necessary to observe how the obligations to provide information - which run through the entire process of formation and execution of the contract - affect the lack of conformity and the right of withdrawal. At the same time, it will be necessary to assess the weight of both the antitrust regulations and the reputational mechanisms of the operators. In particular, the factors that guide and determine the behavior of the user and of the other players will be investigated, in view not only of the change underway (short break, staycation) but also of the numerous obligations prescribed by the regulations which, by translating into constraints and costs to the detriment of quality, feed mistrust rather than solidarity.
