Title: Facial recognition systems and criminal proceedings: evidence reliability and protection of human rights

Offer description - Funded by the European Union - Next Generation EU - PNRR mission 4, component 2, investment 1.1

Facial recognition systems are a new promising tool for social control and the construction of criminal evidence. Still, it raises severe criticism about its reliability as well as on verification and falsification methods and the possible impact on human rights, also within the criminal proceedings context. About these problems, a thorough analysis is necessary, in order to describe and analize the areas in which the legal system should be adapted. The research project will focus on this topic, giving due consideration to the evolving landscape of European sources and policies and, empirically, to the Italian experience with the SARI facial recognition system and the foreign experiences with facial recognition and drone imaging, also focusing on the issues that the COVID-19 pandemic brought forth with regard to this topic.
