Title: Metalanguage of Medieval (early) syntax: on the trail of Port-Royal in the Italian and French rhetoricalgrammatical tradition

Offer description - Funded by the European Union - Next Generation EU - PNRR mission 4, component 2, investment 1.1

The main purpose is to bring out the continuity in the history of syntactic theories in Europe, following the traces of linguistic ideas which foreshadow the birth of Port-Royal Grammar. Starting with the realisation that the formation of modern syntactic concepts and related terminology dates back significantly before the systematisation traditionally identified from the Port-Royal School onwards, the inquiry has to be addressed to the Medieval period, which represents the specific moment when, through the new rhetorical genre of dictamen, early syntactic concepts from the Bolognese School pass in France via rhetorical-grammatical speculations of the treatises regarding this topic. Mostly in the Loire Valley, in the schools of Orléans, the imported Italian theories peculiarly evolved since the XII century, towards a tight bond with the ars grammatica. Generally, forms of syntactic awareness emerge in these texts through rhetorical-grammatical rules that show non-linearity of syntax, and in the status of concepts such as clausulae and distinctiones
