**Title:** Making space for the Other. Opportunities and difficulties in considering the cemetery as a public space for the prefiguration of plural societies

**Offer description:**

Cemeteries in Europe are public spaces and services: however, while they refer to the anthropological transcendental that is death, they often reproduce the divisions of the 'city of the living'. Highly significant places from a symbolic, religious-spiritual and emotional point of view, they are neglected in the reflection on the design, use, accessibility and performativity of public space, just as they are disregarded in the debates on social inclusion (of migrants and minorities), on the dynamics of cohesion, on the conditions of possibility of plural societies of solidarity. The research aims to contribute to bridging this gap from an interdisciplinary approach, by examining and trying to understand the 'cemetery' place through a phenomenologicalhermeneutic methodology that interweaves theoretical reflection and the analysis of some case studies in order to offer, from here, new elements of interpretation and social transformation through a renewed reflection on: (1) the relationship between intimacy and social space; (2) the nature of public space and its performativity; (3) the practices of memory negotiation in multicultural contexts. The aim is thus to show the importance of placing cemeteries at the centre of research and policies on public space.
